Request for Carriage – Handling Advice

Skippers take your child's safety seriously therefore we can only accept a restricted number of unaccompanied minors on each of our flights. Additional details are required to accommodate the needs of an unaccompanied minor.

What is an Unaccompanied Minor (UM)?

- Any child aged 5 to 12 years (inclusive) travelling alone on any Skipper's flight **MUST** be booked as an Unaccompanied Minor (UM).
- If your child is under 13 years of age and is not booked as a UM, the child will be denied travel.
- A child aged 5 to 12 attempting to travel unaccompanied that has not been booked as a UM will be denied travel until an UM booking has been made and availability of carriage can be confirmed.

Terms and Conditions for UM

- If the child suffers from any medical conditions which may affect travel then the child must satisfy our Medical Customer Support Request Form.
- Skippers' cabin crew are unable to administer medication.
- If a child does not satisfy our medical guidelines or requires medication, an UM booking will be denied.
- An UM must be able to attend the toilet unassisted to travel.
- **Both** the **sender** and **receiver** details must be completed at the time of the booking.
- Photo ID will be required when checking in and picking up the child. The details on the ID must match the details on the UM form.
- Your child and sender must arrive at the airport at least 1 hour prior to scheduled departure time.

DECLARATION OF PARENT/GUARDIAN THAT CONTACT DETAILS ARE CORRECT

4. I certify that the child is in possession of all travel documents.

6. I consent to my personal information printed on this form being disclosed to the "Person meeting child on arrival".
7. I confirm that I have signed the above mentioned Unaccompanied Child over to the Airline Staff's care upon departure. I will be available at the airport until the departure of the flight

- This form must be completed for all Unaccompanied Minor/s (UM).
- Children may only travel unaccompanied if they are 5 years of age or older.
- Children under 5 years of age may only travel if accompanied by an adult or a Skippers' escort.
- The Captain shall determine the maximum number of UM's allowed on board.
- UM's must be escorted to and from the aircraft and handed over to either company staff, authorised agents, or the authorised receiver of the child.
- The Unaccompanied Minor/s must be supervised at all times and under no circumstances are to be left in the care of an unauthorised person.
